## Financial/Business Responsibility

I hereby make application for admission to Calvary Christian Academy along with the appropriate registration fees, with the understanding that it is the school's policy not to refund or transfer **registration** fees except for the following:

- 1) One-half of the fee is refundable if later information forces CCA to refuse my application.
- 2) Full fee is refundable if family receives military orders to report to next duty station before the first day of school (must show us a copy of orders).
- 3) One-half the fee is refundable if your job moves you out of our serviceable area before first day of school (need letter on employee letterhead stating start date).

The registration fee is not refundable for any other reason. If I should leave CCA for any reason before the completion of the academic year for which I am registered for, whether voluntary withdrawal or expulsion, I understand that I will owe the tuition and fees for up to and including the month of my withdrawal date. I also understand that I am responsible to pay curriculum fees in full (curriculum fee will not be prorated). In the event of said withdrawal I understand that my transcript and other school records cannot be released until full payment is made. I hereby declare that I have answered all questions on all my application forms truthfully and fully. Further, I give CCA my approval to gather data from all schools in which my child has been enrolled, together with any other records and references that are necessary for the processing of my application.

## Student's Standards of Conduct

Calvary Christian Academy holds that the Bible is the infallible, divine Word of God and that salvation by faith in Christ is the initial step in the Christian life. There is adequate Biblical basis for the idea of spiritual growth into the image of Christ (Romans 8:29), which is the work of the Holy Spirit (II Corinthians 3:18). This growth begins with the initial act of saving faith and continues throughout life. The Holy Spirit makes the Christian conscious of the Biblical demands for a holy life, which fulfills both God's moral law and high law of love (Matthew 22:37-39; Romans 13:8-10; Galatians 5:14). The result is a life consecrated unto God and separated from the world. CCA therefore requests that each student adhere to the following:

- 1) **Whether at school or at home** to refrain from swearing, smoking, drinking alcoholic beverages, the abuse of drugs, pornography, premarital sex, homosexuality, sexual perversion, or satanic worship.
- 2) **Whether at school or a school-sponsored activity** to refrain from indecent or inappropriate language, involvement in rock and roll music, rap music, Christian rock music, or any other music deemed inappropriate by the administration of CCA.
- 3) If accepted to the enrollment of CCA each student will agree to give cheerful and ready obedience to and cooperation with the spirit and regulations of CCA. Each student will further maintain Christian standards of courtesy, kindness, honesty, morality, and modesty.
